- The performance of every municipal entity under the sole or shared control of the municipality, taking into account reports in terms Section 88 from any entities.

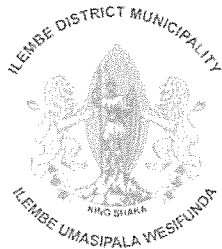
