### **ESTABLISHMENT OF A PANEL OF SUPPLIERS FOR THE SUPPLY AND DELIVERY OF PROTECTIVE CLOTHING/ SAFETY WEAR OVER A 3 YEAR PERIOD**

Bidders are hereby notified that the bid documents for the above-mentioned bid were destroyed by the recent floods that occurred in our Province, therefore the Municipality does not have the necessary supporting documents required to continue with the awarding of this project. It is on this basis that the Municipality issues a notice of cancellation of the bidding process for this project which closed on 22.March 2022. Fresh/new bids are invited from the prospective and qualifying bidders to bid for the establishment of panel of suppliers supply and delivery of protective clothing /safety wear over a 3 year period.

Bid Specification Documents will be available from **Wednesday, 18 May 2022** until the close of business on **Thursday, 26 May 2022 at 15:00** from the offices of the Cashier at iLembe District Municipality, iLembe House, 59/61 Mahatma Gandhi Street, KwaDukuza, upon payment of a **non-refundable cash** deposit of **R500.00**. Bid documents will **NOT** be available at the briefing session.

A **COMPULSORY BRIEFING SESSION** will be held at **10H00 on Friday, 27 May 2022** at the iLembe Auditorium 12 Haysom Road, Kwa-Dukuza. Prospective bidders are required to bring their copies of the bid specification documents to the site inspection.

Failure to obtain a Bid Specification Document and non-attendance of the briefing session will result in the immediate disqualification of your bid. Bids may only be submitted on the bid specification documentation provided by the Municipality.

All bidders must submit a Tax Clearance Certificate, or South African Revenue Services (SARS) UNIQUE PIN to enable the municipality to verify the bidder's tax compliance status online via E-filing. All bidders must be registered on the National Treasury Central Suppliers Database (CSD), and must submit proof of registration.
