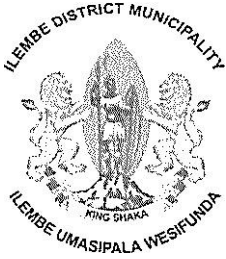

### Section 72(1) (a)

- The municipality's service delivery performance during the first half of the financial year and the service delivery targets and performance indicators set in the service delivery and budget implementation plan;
- The past year's annual report and progress on resolving problems identified in the annual report;
- The performance of every municipal entity under the sole or shared control of the municipality, taking into account reports in terms Section 88 from any entities.




within the municipality and its entity.
